

CHARTER RULES

Please read, sign and date this page - Fax or mail to WWLS with your contract - also keep it for your records.

You are responsible for knowing and complying with these RULES.

YOU ARE A VALUED CUSTOMER OF **Worldwide Limousine Service, LLC** (WWLS) AND WE WANT YOU TO ENJOY YOUR USE OF OUR LIMOUSINE and TOWN CAR. WE JUST WANT TO ENSURE THAT THE INTEGRITY OF OUR LIMOUSINES AND TOWN CAR IS MAINTAINED FOR FUTURE BUSINESS.

Therefore, these rules apply to all transportation (special events, weddings, proms, etc.) provided by WWLS without exception:

1. WWLS agrees to provide the designated LIMOUSINE OR TOWN CAR and a driver at the time, date and location specified on the contract.
2. Unless specified on the contract, request for additional hours will be provided only if the LIMOUSINE OR TOWN CAR is not scheduled for other work.
3. Number of passengers allowed in the LIMOUSINE OR TOWN CAR shall be no more than specified number in contract or limited to the limousine passenger capacity it is designed to carry.
4. WWLS reserves the right to substitute a LIMOUSINE OR TOWN CAR of equal or greater value in the event of mechanical difficulties or scheduling reasons.
5. WWLS and WWLS employees are NOT responsible for any unattended, forgotten, left, lost, damaged or stolen articles in the LIMOUSINE OR TOWN CAR at any time.
6. The sale or use of ILLEGAL DRUGS or smoking in the LIMOUSINE OR TOWN CAR is strictly forbidden. Also, alcohol possession or consumption by minors is strictly forbidden. There will be no standing out of moon-roofs or hanging out of windows. WWLS reserves the right to immediately terminate service without any refund to any party or person(s) who violates these rules.
7. WWLS is not responsible for delays caused by weather, traffic conditions, mechanical problems, airlines and/or airport problems, automobile accidents caused by others or acts of God.
8. Customer may not attach or affix anything to the interior or exterior of the LIMOUSINE OR TOWN CAR without prior permission from WWLS management.
9. Please No Food in our LIMOUSINE OR TOWN CAR.
10. Please No Pets in our LIMOUSINE OR TOWN CAR.
11. Customer accepts full responsibility for LIMOUSINE OR TOWN CAR damage or special cleaning, and any loss of income due to negligence or carelessness cause by any member of customer's group, or customer (examples: vehicle damages caused from smoking, burns, vomiting, scratches, broken glassware stains, wrestling in LIMOUSINE OR TOWN CAR, kicking windows/mirrors, and etc...). There's an automatic \$250.00 cleaning charge for any vomiting. Customer agrees to pay for damages within seven days from the event date. Customer agrees to pay for any collection expenses and/or attorney fees and costs associated with WWLS collection efforts.
12. **FAILURE OF CUSTOMER TO COMPLY WITH THESE RULES AND REGULATIONS WILL RESULT IN TERMINATION OF SERVICE, REQUIRING PAYMENT IN FULL WITH NO REFUND.**
